## Global Business Studies (GBS)

Offered in collaboration with the Copenhagen Business School and The University of North Carolina at Chapel Hill, GBS offers an innovative curriculum taught across three top international business schools in Asia, Europe and America.

## International Business and Chinese Enterprise (IBCE)\*

IBCE trains experts who explore the important Sino-U.S. business relationship and make influential decisions related to two of the world's largest economies. Offered in collaboration with the Darla Moore School of Business at the University of South Carolina, IBCE delivers a cross-cultural learning experience by offering a one-year exchange programme where students can have a genuine cultural immersion.

## BBA-JD Double Degree Programme

The programme combines the strengths of CUHK Business School and Faculty of Law to blend business and legal studies into a rigorous but balanced curriculum. Students graduate with an undergraduate (BBA) degree and a postgraduate (JD) degree in five years, equipped for a variety of career options including community service, business, law enforcement, government service, education, media and beyond.

## Professional Accountancy Programme (PACC)

PACC aims beyond grooming accountants to nurture creative, agile and global-minded business leaders through a whole-person development approach. All students are eligible to sit for professional qualifying exams. The comprehensive curriculum allows students to study extensively on accounting and business subjects and specialise in various streams including the Global Accounting stream, Global Tax and Governance stream, Finance for Accountants stream and Accounting Analytics stream.

## Hospitality and Real Estate Programme (HRE)

The Hospitality and Real Estate (HRE) programme is positioned as a business programme with an industry focus. While the Real Estate stream focuses on planning, developing, and investing in the assets (e.g. buildings and properties), the Hospitality stream focuses on the service element — how to improve service quality, ensure customer satisfaction, and enhance organisational performance. Offering a rich curriculum marrying theory with experiential learning opportunities, HRE puts students right in the heart of the fast-paced hospitality, tourism and real estate industries.

## Insurance, Financial and Actuarial Analysis Programme (IFAA)

IFAA provides comprehensive training in all aspects of actuarial science and insurance company management, including insurance operations, financial markets, portfolio management and derivatives securities, and gives you the knowledge and analytical skills necessary for a career in insurance, financial and actuarial science.

## Quantitative Finance Programme (QFIN)

Our QFIN programme offers comprehensive courses in finance, economics, mathematics, statistics and information technology, through which you will gain a solid command of financial investment instruments and an edge in securing careers in investment, corporate and commercial banking, consulting, accounting and financial services.

## Interdisciplinary Major Programme in Global Economics and Finance (GLEF)

GLEF nurtures global leaders through interdisciplinary training in economics and finance in a global context. The programme caters to industry demands by preparing graduates with strong research and analytical skills, as well as on-the-job experience and the requisite global mindset to overcome challenges in the banking and finance industry.

## Interdisciplinary Major Programme in Quantitative Finance and Risk Management Science (QFRM)

Jointly offered by CUHK Business School and the Faculty of Science, this state-of-the-art programme in finance, risk management science, statistics and business combines the strengths of two well-established programmes to provide a solid foundation for finance careers or further studies, at the Master's or PhD level, in economics, finance, actuarial science and insurance, mathematics, statistics, and risk management science.

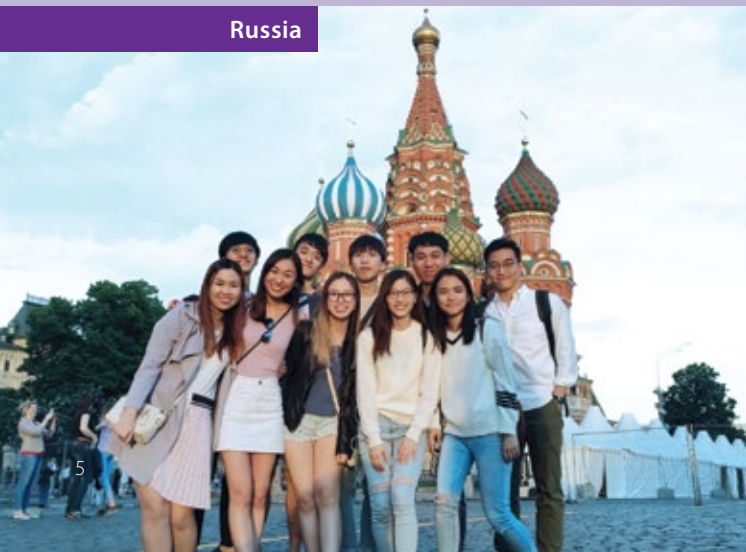

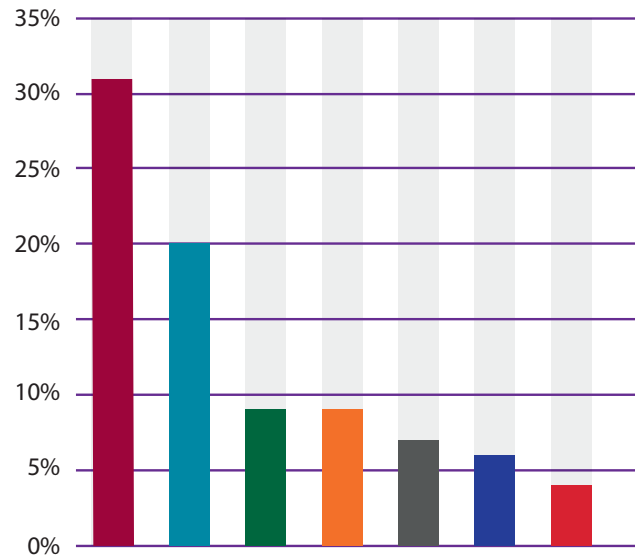

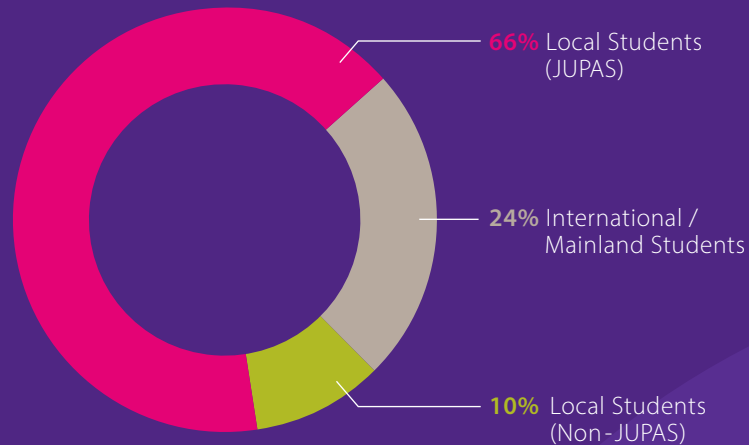

## Building a Base

Your CUHK Business School curriculum will begin with an overview of business fundamentals including Economics, Management and Accounting. These Faculty Package classes will be taken during your first year and serve as the foundation for the rest of your education.

Complementing your business foundation are University Core Courses intended to build out your well-rounded development. They include Chinese, English, Information Technology, Physical Education, and General Education courses.

## Time for Specialisation

Your Major Required and Elective Courses provide you with in-depth knowledge to take your education to the next level. You'll be able to select electives that allow you to explore different areas of interest.

You will have opportunities to pursue personal aspirations with Free Elective Courses. Your remaining credits will come from this category and you may choose electives inside or outside of your business major.

# ADMISSIONS & SCHOLARSHIPS

## JUPAS Students

Local students applying on the strength of their Hong Kong Diploma of Secondary Education (HKDSE) Examination should apply through JUPAS.

Each programme has its own minimum requirements for admittance. Please visit our website ([www.bs.school.cuhk.edu.hk/ug](http://www.bs.school.cuhk.edu.hk/ug)) or consult the individual programme materials for details.

## Minimum Entrance Requirements for Admission to CUHK Business School

**Level 3 or above** in English Language

**Level 3 or above** in Chinese Language

**Level 2 or above** in Mathematics (Compulsory Part)

**Level 2 or above** in Liberal Studies

**Level 3** in any two elective subjects, including:

**1. Two New Senior Secondary elective subjects**

or

**2. One New Senior Secondary elective subject and Mathematics (Extended Part) Module I or Module II**

## Non-JUPAS (Local) Students

You may also apply on the strength of your qualifications other than HKDSE. These include but are not limited to the following: International Baccalaureate (IB), GCE A-Level/International A-Level, Cambridge Pre-U, HKALE, Associate Degree, or other comparable secondary level qualifications.



## International Students

If you require a student visa to study in Hong Kong and possess one of the below qualifications, you are welcome to apply through the Non-JUPAS admission scheme:

- GCE A-Level/International A-Level;
- International Baccalaureate Diploma;
- A recognised non-local qualification for admission to a university in the country/region of its origin (e.g. high school diploma plus SAT/AP in the USA, UEC/STPM in Malaysia, ATAR in Australia, OSSD in Canada, GSAT in Taiwan). For more information, please visit:

## Mainland Students

You may apply on the basis of your results in the nation-wide Joint Entrance Examination. Please apply through the National Colleges and Universities Enrolment System. For more information, please visit:

If you are not covered by the National Colleges and Universities Enrolment System, you should apply through the International Admissions Scheme.

## Advanced Standing

Applicants who meet specific requirements as stipulated by the University may apply for "Admission with Advanced Standing". The minimum total number of units required for graduation may be reduced by up to 24 and such the normative period of study may be reduced by up to one year.

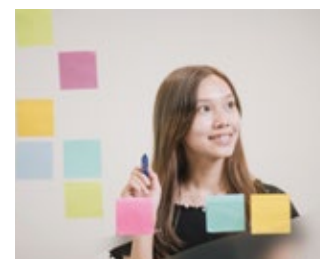
## Scholarships and Financial Aid
