Approximately 30% of PACC students study a minor. We offer many minor options to help you broaden your scope of studies and bring a new perspective to your major work.

Diverse Choice of Streams

Within the PACC programme curriculum, students can choose to specialise in various streams in addition to the core accounting courses, including Global Accounting, Finance for Accountants, Accounting Analytics, and Global Tax and Governance.



Global Accounting (GA) Stream

This stream is offered to elite accounting students who aspire to become business leaders with a global mindset as well as comprehensive understanding of international accounting and business practices. Students may apply for this stream after completing their first year of study. Students in this stream will sharpen their skillsets and enrich their employment attributes through a range of workshops and overseas study trips. Students in this stream will also be awarded scholarships based on academic merit.



Finance for Accountants (FA) Stream

As a premier global financial hub, there has been a rising demand in Hong Kong for talented professionals capable of integrating accounting and financial knowledge. The PACC programme responds to this growing demand by offering the Finance for Accountants stream. Students in this stream are expected to take core accounting courses with another comprehensive set of finance courses. By integrating their expertise in both accounting and finance, students are well-prepared for careers in the financial sector, with specialisation in areas such as banking, corporate finance, portfolio management, international finance, and financial market regulation.







Accounting Analytics (AA) Stream

With the rapid expansion of data volumes and advanced computational tools, deriving deep insights from diverse business data has become increasingly important for decision making. Consequently, various organisations, including banks, firms, and regulators, are actively seeking accountants with solid skills in big data analytics to help them deepen their insights about their business through accounting and other related data. The PACC programme offers the Accounting Analytics stream to meet this increasing demand for professionals capable of analysing big data with expertise in accounting knowledge. Students in this stream will take multiple data analytics courses in addition to core accounting courses. Graduates are equipped with both accounting expertise and data analytics proficiency, positioning them for success in accounting, finance, consulting, and other business roles that demand advanced data analysis.



Global Tax and Governance (GTG) Stream

With tax regulations and monitoring becoming ever more complex globally, the demand for skilled tax professionals with accounting expertise has been significantly increasing. The Global Tax and Governance stream addresses the increasing demand for accounting graduates proficient in accounting, taxation, compliance, and governance. Students in this stream will take core accounting courses with additional specialised tax courses. In addition to the paper exemptions from several accounting professional qualification examinations, students in this stream can also receive paper exemptions for the Chartered Tax Adviser (CTA) qualifying examination offered by the Taxation Institute of Hong Kong (TIHK). Graduates generally work in tax advisory and compliance industries.

Most PACC students acquire internship experience prior to their final year of study, which greatly enhances their competitiveness in the job market.



Admission

JUPAS Students

Local students applying on the strength of their Hong Kong Diploma of Secondary Education (HKDSE) Examination should apply through JUPAS.

JUPAS code: JS4240

Minimum Entrance Requirements

Level 3 in English Language, Chinese Language and Mathematics (Compulsory Part)

Level 3 in two best New Senior Secondary (NSS) Elective Subjects

"Attained" in Citizenship and Social Development

Admission will be based on the score of the best 5 subjects. The "Attained" level in the subject will not be considered in the calculation of admission scores.

Non-JUPAS & International Students

You are eligible to apply for admission, if by 1 September of the year in which admission is sought, you possess any of the following qualifications:

- GCE AL/International AL: 3AL/2AL+2AS
- International Baccalaureate Diploma
- A recognised non-local qualification which qualifies you for admission to a university in the country/region where such qualification is originated (e.g. high school diploma plus SAT/ ACT/ AP in USA, OSSD/ BC diploma in Canada, ATAR in Australia, UEC/ STPM in Malaysia, AISSCE (CBSE)/ ISC in India, SMA in Indonesia, etc.)

Applicants who meet specific requirements as stipulated by the University for particular qualifications may apply for "Admission with Advanced Standing". The minimum number of units for graduation for students admitted with Advanced Standing may be reduced by up to 24 (normative period of study may be reduced by up to one year).
