Our Programmes

IBBA Integrated BBA Programme

IBBA offers a flexible curriculum to make your personal aspirations come true. Learn essential business fundamentals from our world-class faculty and gain specialist expertise via up to two concentrations (out of nine options). There is no quota limitation on each individual concentration. You can choose your concentration(s) based on your interests, strengths and aspirations. You can also adjust your areas of concentration along the academic journey.

GBS Global Business Studies

GBS offers a distinctive, internationally oriented curriculum designed to cultivate students' global perspective, business acumen, entrepreneurial mindset, and the adaptability essential for leadership in today's dynamic world. Through dual exchange programme with top universities in Europe and North America, complemented by immersive study trips in Asia, students engage in personalised experiential learning across three continents, gaining cross-cultural fluency, real-world experience, and global competence. Our small cohort model fosters deep collaboration, further enriched by a tight-knit alumni network that provides mentorship and opens doors to international professional networks. GBS graduates emerge with the global outlook, strategic skillset, and leadership capabilities to drive impact and thrive on the world stage.

BBA-JD BBA-JD Double Degree Programme

The programme combines the strengths of CUHK Business School and the Faculty of Law to blend business and legal studies into a rigorous but balanced curriculum. Students will graduate with an undergraduate (BBA) degree and a postgraduate (JD) degree in five years, equipped with a variety of career options including community service, business, law enforcement, government service, education, media, and beyond.

IFAA Insurance, Financial and Actuarial Analysis Programme

IFAA is a programme tailored for those who wish to be actuaries. Students receive training in actuarial science, insurance and data analytics, as well as finance such as portfolio management and derivatives. The programme is accredited by the Society of Actuaries in the US as a Center of Actuarial Excellence with University-earned credit programme.

PACC Professional Accountancy Programme

PACC emphasises accounting as an information system to enhance management practices and create value for corporations. The programme features a comprehensive curriculum to cultivate visionary business leaders with expertise in accounting, finance, data analytics, and general business, alongside strong leadership mindsets and skills. Students can choose to specialise in various streams, including Global Accounting, Finance for Accountants, Accounting Analytics, and Global Tax and Governance. All PACC graduates are entitled to exemptions from multiple subjects in various accounting and related professional qualifying exams.

HRE Hospitality and Real Estate Programme

Hospitality and real estate are interwoven industries offering innovative business opportunities and diverse career paths. HRE programme is a pioneer in Asia, uniquely blending the strengths of both sectors to provide a holistic, future-ready education. Through an interdisciplinary approach, our curriculum integrates insights from business, design, technology, finance, and human behaviour - empowering students to solve complex, real-world challenges. Advocating for the experience economy, the programme focuses on creating meaningful experiences beyond traditional service models. Courses cover the entire industry landscape - from the "front stage" of service management and marketing, where guest experiences are shaped, to the "back stage" of asset development and investment, where strategic decisions are made. We aim to cultivate visionary leaders to drive global impact in hospitality and real estate.

QFRM Interdisciplinary Major Programme in Quantitative Finance and Risk Management Science

Jointly offered by CUHK Business School and the Faculty of Science, this state-of-the-art programme in finance, risk management science, statistics and business combines the strength of two well-established programmes to provide an unparalleled foundation for securing careers in finance or admission to top postgraduate study programmes. With a rock-solid theoretical understanding enhanced by active exposure and engagement in real-world applications, our students prove to be excellent candidates for jobs in all areas of finance, especially commercial and investment banking, as well as successful applicants to internationally-renowned Master's or PhD programmes.

QFIN Quantitative Finance Programme

QFIN cultivates students into skilled financial professionals by equipping them with comprehensive knowledge of finance, economics, mathematics, statistics, and programming while emphasising the practical application of the knowledge in real-world scenarios. Armed with a robust knowledge base and hands-on experience, students are empowered to pursue careers in diverse financial fields such as investment banking, equity research, wealth management, portfolio management, trading, quants, and more.

GLEF Interdisciplinary Major Programme in Global Economics and Finance

GLEF nurtures global leaders through interdisciplinary training in economics and finance in a global context. The programme caters to industry demands by preparing graduates with strong research and analytical skills, as well as on-the-job experience and the requisite global mindset to overcome challenges in the banking and finance industry.

BEHM Biotechnology, Entrepreneurship and Healthcare Management

This programme is designed for talented students who would like to develop a career in biotechnology entrepreneurship, business analysis, and/or healthcare management, to capture the emerging opportunities in Hong Kong, the Greater Bay Area, and beyond. The programme brings together the Faculties of Science, Medicine, and Business Administration at the Chinese University of Hong Kong to co-develop a brand-new, integrated curriculum with active learning as the core.

IDADM Interdisciplinary Data Analytics + X Double Major Programme

IDADM is a comprehensive collaborative Double Major Programme jointly offered by the Chinese University of Hong Kong (CUHK) and the Chinese University of Hong Kong (Shenzhen). Students will pursue a first Major in Interdisciplinary Data Analytics offered by CUHK, and a second Major among specific academic disciplines (Business, Engineering and Science) offered by either the Chinese University of Hong Kong or the Chinese University of Hong Kong (Shenzhen).

Transfer-in for CUHK Year 1 students

IBCE International Business and Chinese Enterprise*

IBCE develops experts with specialised knowledge in two of the world's largest economies, the US and China. In collaboration with the University of South Carolina (USC)'s Darla Moore School of Business, IBCE provides a unique bi-continental cohort learning experience. Students from both institutions engage in a one-year cohort exchange programme, immersing themselves in genuine cultural experiences. The curriculum offers specialised courses and enrichment activities on Chinese enterprises and markets, enhancing your business skills and career readiness. Through a "4+1" structure, students can pursue a one-year Master of International Business (MIB) programme at USC.

ABS Asian Business Studies*

ABS nurtures visionary leaders with unparalleled insights into Asia, a dynamic and thriving market that spearheads global economic growth in the new century. With the opportunity to embark on up to two exchange terms at institutions across Asia, students will experience cross-cultural learning tailored to their academic and personal goals. The corporate capstone project is designed to equip students with industry exposure and practical training in Asian business. These experiences will not only foster lasting friendship but will also give students access to an expansive Asian network filled with driven professionals.

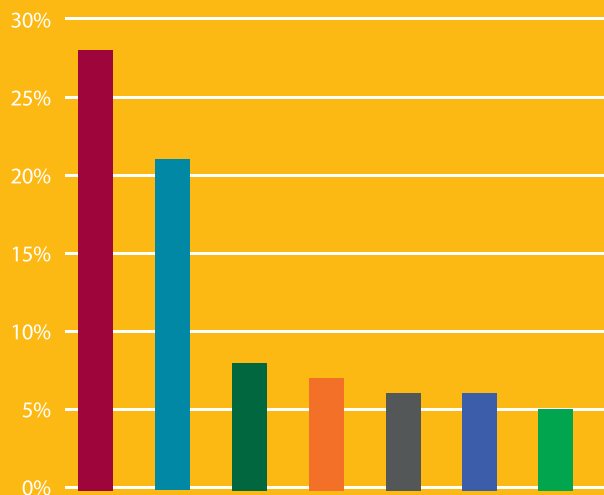

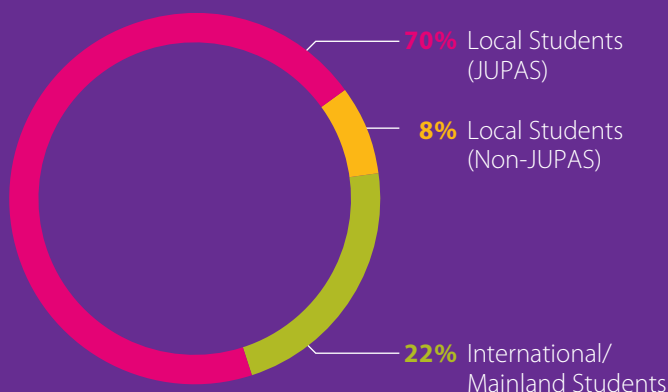

Building a Base

Your CUHK Business School curriculum will begin with an overview of business fundamentals including economics, management and accounting. These Faculty Package classes will be taken during your first year and serve as the foundation for the rest of your education.

Complementing your business foundation are University Core Courses that intend to build out your well-rounded development. They include Chinese, English, information technology, physical education, and general education courses.





Time for Specialisation

Your major required and elective courses provide you with in-depth knowledge to take your education to the next level. You will be able to select electives that allow you to explore different areas of interest.

You will have opportunities to pursue personal aspirations with a wide range of free elective courses. Your remaining credits will come from this category and you may choose electives inside or outside your business major.



Expanding Your Potential

Admissions & Scholarships

JUPAS Students

Local students applying on the strength of their Hong Kong Diploma of Secondary Education (HKDSE) Examination should apply through JUPAS.

Each programme has its own minimum requirements for admittance. Please visit our website (www.bschool.cuhk.edu.hk/ug) or consult the individual programme materials for details.

Minimum Entrance Requirements for Admission to CUHK Business School

Level 3 or above in English Language

Level 3 or above in Chinese Language

Level 2 or above in Mathematics (Compulsory Part)

A (Attained) in Citizenship and Social Development**

Level 3 in any two elective subjects, including:

1. Two elective subjects

or

**2. One elective subject
and Mathematics (Extended Part)
Module I or Module II /
Other Language subject^**

* The "Attained" level in Citizenship and Social Development (CS) will not be considered in the calculation of admission scores.

For Liberal Studies (LS) subject taken in 2023 or before, a Level 2 or above will be considered as "Attained" in Citizenship and Social Development. The LS level will not be considered in the calculation of admission scores.

^ Please visit (<https://admission.cuhk.edu.hk/application/jupas/faq/>) and refer to FAQ #10 for the minimum requirements of Category C - Other Language Subjects.

Non-JUPAS (Local) Students

You may also apply on the strength of your qualifications other than HKDSE. These include but are not limited to the following: International Baccalaureate (IB), GCE A-Level/ International A-Level, Cambridge Pre-U, HKALE, Associate Degree, or other comparable secondary-level qualifications.



International Students

If you require a student visa to study in Hong Kong and possess one of the below qualifications, you are welcome to apply through the Non-JUPAS admission scheme:

- GCE A-Level/International A-Level;
- International Baccalaureate Diploma;
- A recognised non-local qualification for admission to a university in the country/region of its origin (e.g. high school diploma plus SAT/AP in the USA, UEC/STPM in Malaysia, ATAR in Australia, OSSD in Canada, GSAT in Taiwan). Mainland Students

You may apply based on your results in the nationwide Joint Entrance Examination. Please apply through the National Colleges and Universities Enrolment System. For more information, please visit: <http://admission.cuhk.edu.hk/sc/mainland/requirements.html>

If you are not covered by the National Colleges and Universities Enrolment System, you should apply through the International Admissions Scheme.

Advanced Standing

Applicants who meet specific requirements as stipulated by the University may apply for "Admission with Advanced Standing". The minimum total number of units required for graduation may be reduced by up to 24 and such the normative period of study may be reduced by up to one year.

Scholarships and Financial Aid

Students achieving academic excellence and outstanding performance in other fields such as creativity, community services and leadership may be awarded scholarships from the Business School. Scholarships and financial aid are also available from the University and the Colleges.
